# AUTHORIZING A REQUEST TO THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR A TIME EXTENSION TO UTILIZE FY2024 MUNICIPAL AID GRANT FUNDS FOR THE EDGEWATER DRIVE ROADWAY IMPROVEMENTS PROJECT

WHEREAS, the Borough of Matawan was awarded a Fiscal Year 2024 Municipal Aid Grant in the amount of \$288.101.00 by the New Jersey Department of Transportation (NJDOT) for the Edgewater Drive Roadway Improvements Project, under grant reference LA-2024 MA Matawan Borough Edgewater Drive Roadway Improvements; and

WHEREAS, the project scope includes roadway milling and paving, ADA-compliant curb ramps and driveway aprons, drainage improvements, water main replacement, lead service line replacement, and sanitary sewer trenchless rehabilitation; and

WHEREAS, due to recent changes in professional personnel and project management, additional time is required to complete design, plan review, NJDOT Local Aid approvals, and the bid/award process; and

WHEREAS, NJDOT regulations require that all Fiscal Year 2024 Municipal Aid projects be awarded within two years of the grant notification date, or by October 31, 2025, to avoid forfeiture of funds; and

WHEREAS, the Borough Engineer and municipal officials are actively working to advance the project, but seek to preserve the awarded funds and therefore require an extension of time.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Matawan. County of Monmouth, State of New Jersey, that the Borough formally requests a sixmonth time extension from the New Jersey Department of Transportation to retain the awarded Fiscal Year 2024 Municipal Aid funding for the Edgewater Drive Roadway Improvements Project.

Confirming Proposal for Design, Inspection and Construction Administration Services

2025 NJDOT Municipal Aid Program Grant

Eisenhower Court and MacArthur Drive Improvement Project

Dear Mr. Michelson:

The Borough of Matawan received notification from the NJDOT that it received a \$299,002.00 grant under the NJDOT's 2025 Municipal Aid Program to fund eligible road improvements for the full-depth pavement reconstruction of Eisenhower Court and MacArthur Drive. Additional work to be done includes selective curb and driveway apron replacement, drainage upgrades, water main and service line replacements (including addressing potential lead/galvanized lines), and sanitary sewer rehabilitation.

These funds can be used for applicable services under the Municipal Aid Program Rules, including but not limited to construction (i.e. paving, curbing and eligible appurtenant improvements), design fees (grant reimbursable up to 5% of the grant amount) and inspection fees and material testing service fees (grant reimbursable up to 15% of the project construction costs).

Additionally, please note that based on current NJDOT policy, contract administration services are not reimbursable under the NJDOT grant. We will require up to \$5,000 for necessary contract administration services for this project. Please also note that the NJDOT does NOT participate in the payment for police officers and vehicle services. This cost is to be paid by the Borough and is NOT NJDOT grant reimbursable.

Due to the amount of work requested, the construction cost of this project surpasses the grant amount. As such, the grant would be fully utilized for a portion of the construction costs. The Borough would have to fund the survey, design, inspection, contract administration, & the excess construction costs directly.

We respectfully request authorization to proceed with design, bid and inspection of road improvements fundable by this grant. Once authorized, we will meet with the Borough and public works officials to determine what areas are prioritized for construction prior to completing necessary design plans, specifications and bid documents.

Our lump sum fee is based on the scope as known at this time. If unforeseen and/or unanticipated work items arise, our office shall provide a separate or amended scope of services & cost proposal for consideration and approval.

Our lump sum fee will be billed monthly based on the percent complete of each phase.

Assuming that the \$299,002.00 grant will be utilized fully to fund eligible construction for this project, said fees would be as follows:

Construction services will include the preconstruction meeting, project meeting, administration of the contract, and preparation of pay documents & change orders. RVE will coordinate the project with all Borough departments and the surrounding community. RVE will provide field construction observation to ensure compliance with contract documents. All observations will be recorded in observation reports.

#### **ORDINANCE 25-17**

# AMENDING AND SUPPLEMENTING THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF MATAWAN CHAPTER 10 – USE OF MUNICIPAL BUILDINGS SECTION 10-2.2 – INSURANCE

BE IT ORDAINED by the Mayor and Council of the Borough of Matawan, County of Monmouth, State of New Jersey, that Chapter 10 - Use of Municipal Buildings Section 10-2.2 - Insurance of the Revised General Ordinances is hereby amended as follows:

#### Insurance Section 10-2.2

The Borough shall, in all instances, require a certificate of insurance. The limits of the policy shall be \$100,000 each person, \$100,000 each accident for bodily injury, and \$100,000 for property damage liability, and an excess liability of one million (\$1,000,000.00) dollars which is equal to the Borough's coverage. The Borough of Matawan shall be named as an "additional insured" on all certificates of insurance. All insurance certificates are to be submitted 10 days prior to the event to the Borough Clerk's Office.

All certificates must contain the following language:

"The applicant shall indemnify, defend, and hold harmless the Borough of Matawan, its officers, agents, and employees from and against any and all claims, damages, losses, and expenses (including reasonable attorney's fees) arising out of or resulting from the applicant's use of the premises, except to the extent caused by the Borough's sole negligence or willful misconduct."

Applicants do not require an insurance form if they are insured under the policies of the Borough of Matawan.

Due to insufficient insurance, the Matawan Community Center (MMCC) will not be rented to individuals for personal events. Example: Baby shower, etc.

BE IT FURTHER ORDAINED, any Ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies only.

BE IT FURTHER ORDAINED, if any provisions of this Ordinance, or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance, which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

BE IT FURTHER ORDAINED, this Ordinance shall take effect immediately upon following the passage, adoption and publication pursuant to New Jersey State law.
