**NOTICE IS HEREBY GIVEN**, for all applications in positions set forth more fully in a notice of publication authorized by the Governing Body of the Borough of Matawan, for submission of qualifications that shall take into consideration the following factors which will be weighed by the governing body of the Borough of Matawan or by the Unified Planning and Zoning Board of Adjustments in the case of the Planning/Zoning Professionals, as the basis of an award for professional services most advantageous to the Borough of Matawan:

Each interested firm shall submit a proposal containing the following information:

1. Name of Firm;
2. Address of principal place of business and all attorneys or firm's offices and corresponding telephone and fax numbers. Please note specifically which attorney(s) will be assigned to work with the Borough;
3. Rate Schedule for all Personnel (Secretarial, Clerical and the like are not reimbursable);
4. Areas of Practice;
5. Description of firm's attorneys' education, experience, qualifications, number of years with the firm or other firms and a description of their experience with projects similar to those described above;
6. Experience related to representation of public entities and knowledge and experience with the Borough of Matawan;
7. The firm's ability to provide the services in a timely fashion (including staffing, familiarity and location of key staff);
8. Any other information that the interested firm deems relevant;
9. All Items Outlined in the Proposal Checklist;
10. A certificate of insurance issued by a producer or insurer, showing professional liability coverage for at least \$500,000/\$1,000,000. The certificate should show the Borough of Matawan as the certificate holder. The certificate should provide that the insurer will endeavor to send a notice to the certificate holder if coverage is cancelled prior to the policy expiration date. ## Scope of Consultant Services for Analysis and Assessment of the Matawan Fire Department

### Intent

The Borough of Matawan is seeking qualifications from experienced and qualified consultants to perform a comprehensive analysis and assessment of the Matawan Fire Department. The goal of this project is to evaluate the current state of the department and provide actionable recommendations to guide its future development, ensuring effective and efficient fire protection services for the community.

### Scope of Services

The selected consultant will be tasked with addressing three main objectives as part of the assessment:

1. **Firehouse and Company Consolidation:**
  - Evaluate the current structure of firehouses and companies.
  - Provide recommendations and a timeline for consolidation to enhance operational efficiency and resource allocation.
2. **Assessment of Assets and Equipment Needs:**
  - Conduct an evaluation of current apparatus, facilities, and equipment.
  - Develop a comprehensive plan outlining needs for the next 5, 10, and 25 years, ensuring readiness to meet future demands.
3. **Staffing Needs and Volunteer Recruitment:**
  - Analyze current and projected staffing requirements for the next 25 years, including volunteer, part-time, and full-time personnel.
  - Identify recognized incentive programs and strategies to attract and retain volunteers.
  - Recommend staffing models to ensure sustainable operations.

### Deliverables

The consultant will provide a detailed report addressing the above objectives. The report must include:

- A timeline for consolidation implementation.
- A prioritized list of asset and equipment needs over specified timeframes.
- A staffing plan with actionable steps to attract and retain qualified personnel, including incentive program recommendations.
- Data and analysis to support all recommendations.

**Deadline:** The final deliverable must be completed and submitted to the Borough of Matawan no later than **April 25, 2025**.

### Consultant Qualifications

- Expertise in fire department operations, planning, and consolidation.
- Experience conducting similar assessments for municipal fire departments.
- Strong analytical and communication skills, with the ability to present complex findings clearly.
- Knowledge of applicable state and federal regulations, as well as best practices in fire services.

The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation. The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim. If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the *owner shall* expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.
