**Resolution 26-04-04**  
**Award of Contract for Solid Waste & Recyclable Materials**  
**Collections Service in the Borough of Matawan**

**Jersey Specialized Hauling, Inc.**

**WHEREAS**, the Borough of Matawan is in need of a new contract for the solid waste and recyclable materials collection services in the Borough of Matawan; and

**WHEREAS**, pursuant to law the Borough of Matawan has sought bids for the aforesaid contract and received two (2) bids for the aforesaid contracts; and

**WHEREAS**, the Borough of Matawan has determined that Solid Waste Option 1, Items 1A+2+3, and Recyclable Materials Option 2, Item 1A, is the most cost-effective combination to properly service the Borough residents which represents a continuation of the same services provided to the Borough from the prior contract; and

**WHEREAS**, Jersey Specialized Hauling, Inc., located at 391 Mounts Mills Road, Monroe, New Jersey 08831, has submitted the low bid in the amount of \$2,071,022.00 for Solid Waste Option 1, Items 1A+2+3, and \$1,484,614.64 for Recyclable Materials Option 2, Item 1A, for a period of five year contract, starting May 11, 2026 and ending May 10, 2031; and

**WHEREAS**, T&M Associates, the Borough of Matawan Engineer, has reviewed, approved and recommended the bid of Jersey Specialized Hauling, Ing. for the aforesaid bid.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Borough of Matawan that the contract for the Solid Waste and Recyclable Materials Collection Service be and is hereby awarded to Jersey Specialized Hauling, Inc. for Solid Waste Option 1, Items 1A+2+3, and Recyclable Materials Option 2, Item 1A, in the amount as indicated above and in accordance with all bid specifications, contracts and documents, commencing twenty (20) days after publication, and subject to certification by the Chief Financial Officer that funds are available, review and approval of bid documents by the Borough Attorney, and approval of the New Jersey Department of Labor, Division of Wage and Hour Compliance, approval of the New Jersey Department of Transportation and the Mayor is hereby authorized to execute any necessary documents to implement the aforesaid award of contract, commencing twenty (20) days after publication.

**BE IT FURTHER RESOLVED** that a true certified copy of this Resolution shall be forwarded to the Borough of Matawan Department Heads, T&M Associates and Jersey Specialized Hauling, Inc.

A true certified copy of this Resolution and written contract shall be on file and available for public inspection in the office of the Municipal Clerk.
