# 1.0 EXECUTIVE SUMMARY

The Matawan Borough Environmental Commission (MBEC) was recently re-established in 2018 in accordance with Code § 2-8.1 with the purpose of the protection, development and use of natural resources, including water resources located within the Borough (Code § 2-21.3). As well as NJ State Legislation 40:56A which established environmental commissions to "study and make recommendations concerning open space preservation, water resource management, air pollution control, solid waste management, noise control soil and landscape protection, environmental appearance, marine resources, and protection of flora and fauna."

In accordance to Code § 2-33.5 the MBEC has the following powers and duties:

- a. Subject to the prior approval of the Unified Planning Board and Council, the Commission may acquire property, both real and personal, in the name of the Borough, by gift, purchase, grant, bequest, devise or lease, for any of the purposes of the Commission and it shall administer the same for such easement (including conservation easement), covenant or other contractual right (including a conveyance on conditions) as may be necessary to acquire, maintain, improve, protect, limit the future use of, or otherwise conserve and properly utilize open spaces and other land and water areas in the Borough.
  - b. Conduct research into the use and possible use of the open land areas of the Borough.
- c. To advertise, prepare, print and distribute books, maps, charts, plans and pamphlets, which in its judgment it deems necessary for its purposes, within the limits of funds appropriated to the Commission.
  - d. To coordinate the activities of unofficial bodies organized for similar purposes.
- e. Keep an index of all open areas, publicly and privately owned, including open marsh lands, swamps, and other wetlands, and to obtain information on the proper use of such areas.
- f. Recommend from time to time to the Unified Planning Board, plans and programs for inclusion in the Master Plan of the Borough for development and use of such areas.
- g. To do such other acts and things as are reasonably related to and designed to carry out the purposes and objectives of the Commission, including without limitation, the appointment and payment of such clerks and other employees of the Commission which may be required within the limits of the funds appropriated to the Commission.
- h. Keep records of the meetings and activities of the Commission and make an annual report to the Borough Council. (1971 Code § 2-21.5)

# 2.0 MEMBERS

The Matawan Borough Environmental Commission consists of seven members who shall be appointed by the Mayor for a term of three years, and associate members chosen by the commission for a term of one year. All members of the Commission are residents of the Borough.

# 5.0 2018 HIGHLIGHTS AND ACCOMPLISHMENTS

## 5.1 Facebook

Being that interest on the All About Matawan Facebook page was one of the driving forces in the re-establishment of the MBEC we wanted to quickly establish a social media presence to let the community know about the commission.

In the past year alone, our posts have reached over 1,800 people, acquiring 175 followers, 170 likes. Over 400 people reacted to or engage to the close to 200 posts made by the commission.

# 5.2 Environmental Workshop

The Matawan-Aberdeen Educational Foundation (MAEF) in conjunction with the Matawan Borough Environmental Commission held a workshop on community environmentalism and technology on February 26, 2018, 4-6 PM in the MAMS Cafeteria.

We were visited by Tobias Fox, the Director of **Newark Science and Sustainability**. Mr. Fox is a long-time community leader in building local resources for public education, community gardens, nutritional awareness, eco-art, sustainable technology, and youth mentoring. Newark SAS has been expanding its reach in the Newark area and statewide. He gave us a presentation on what they've been doing, and their plans.



After Mr. Fox's presentation -- and a taste of their pedal-powered smoothies! -- we had an open, structured discussion about possible projects that could involve our town governments, our schools, our civic organizations, our local businesses, garden clubs, youth groups, seniors -- everybody who's got something to share. We want to preserve the best of the past as we prepare for a clean, comfortable, exciting future.

Kizzie Osborne of the Aberdeen Environmental and Shade Tree Advisory Board, and Dan Wieczorek and Jim Tobias of Matawan Borough Environmental Council respectively, led the discussion on what projects are under discussion or underway.

# 5.3 MARSD Sustainability - Community Meeting

In Members of the Matawan and Aberdeen communities, including the Matawan Borough Environmental Commission, met with Adam Nasr, the Director of Facilities for the Matawan-Aberdeen Regional School District (MARSD), to discuss what the district is doing in terms of sustainability, and what we might all do.

Adam gave short us а presentation on district facilities, which are both wide ranging and complex (slides available). He has overseen many recent improvements that have resulted in better performance and lower cost, such as the boilers replaced in several buildings. As MARSD spends \$1.2M annually on utilities, these improvements have already had a financial impact as well as reduced carbon emissions. As example of how these changes are reflected in sustainability, MAMS's EnergyStar score moved from 29 to 91. Other facility

changes underway include LED lighting, recycling, revised cleaning materials and processes, and water filtration.

Adam then moved the conversation to how to manage and advance the issue of sustainability in an organizational sense. He walked us through the process of setting up a Green Team and completing specific sustainability actions that enhance quality of life and community value, while reduce overall costs. These actions and lots of supporting materials are found on the Sustainable Jersey website. Both municipalities and schools are eligible to participate and can follow its rubrics to score points leading to escalating levels of certification. Grants of different amounts are available to Green Teams for special projects, based on their certification levels.

We discussed several ways the community could help, especially by establishing Green Teams in our municipalities and supporting MARSD through awareness campaigns.

# 5.4 2018 New Jersey Sustainability Summit

Commission members joined over 350 state and municipal representatives from across the political, private and public sectors at the 2018 New Jersey Sustainability Summit on June 21, 2018 to take stock together on a path for a sustainable New Jersey. The one-day sustainability summit included a keynote address from First Lady Tammy Murphy, and a total of 12 breakout sessions with topics ranging from "goin' green by makin' green" and "it's electric" to "plastic pollution solution."

# 5.5 Henry Hudson Trail Extension

The Environmental Commissions of Aberdeen and Matawan, along with the administration and governing bodies of both municipalities, attended a meeting in March 23, 2018 with the Monmouth County Parks System and NJ Transit. The purpose of this meeting was to discuss the remaining connections necessary to make the Henry Hudson (HH) Trail one contiguous trail through Aberdeen and Matawan. The project is being pursued by NJ Transit and they were seeking permission from Matawan Borough and Aberdeen Township to pursue a transit trail that will connect the trail from around (Stillwell St) the old railbed to the Aberdeen Matawan Train Station. The old trestle bridge north of Stillwell will be renovated or replaced and the trail improved to be what they consider an 'enhanced' trail that includes a walkway for pedestrians, a bike trail, lighting and signage to the train station. The trail could also go all the way to the Santa Fe Junction Neighborhood at Nutmeg Road (Aberdeen) if residents concur.



The benefits of this trail expansion to both towns would be tremendous as it will make it easier for commuters to bike and walk to the train station and the HH trail. In addition, residents who utilize the trail for leisure will be able to enjoy a more cohesive and connected trail experience. Although

this project is years away from completion, we will continue to monitor the project and keep people apprised of its status.

# 5.6 First Annual Matawan Environmental Commission Spring Cleanup

The Matawan Environmental Commission held its first annual Spring Cleanup on Saturday April 14, 2018. The event attracted over 50 people, including Scouts, students, and Matawan Council members. Volunteers met at Lake Lefferts Lakefront Park, a public space for fishing, kayaking, and picnicking where Commission members introduced themselves and discussed the cleanup route. Will Johnson, Coordinator for Monmouth County Clean Communities, gave a brief safety talk and provided gloves, pickers, safety vests, and trash bags. Volunteers made their way from Lake Lefferts Lakefront Park to Terhune Park, collecting litter and debris from the lakefront, side streets, and marsh areas along the way. The cleanup ended at Terhune Park. The tonnage report provided by Monmouth County Clean Communities reported 48 bags of trash and 10 bags of recyclables were collected, totaling 580 lbs. Matawan Department of Public Works also helped facilitate the day's activities and coffee was donated by Matawan's Starbucks.







# 5.7 Sandy Recovery Tree Giveaway

The Department of Environmental Protection's Division of Parks and Forestry is making has made free tree seedlings available to residents through the New Jersey Tree Recovery Campaign, an ongoing effort of the New Jersey Forest Service, the nonprofit Arbor Day Foundation and other partners. As a participant in the program Matawan was proudly listed as a distribution center and gave away over 250 willow oak, and dogwood seedlings.





# 5.8 Matawan Day

The Matawan Environmental Commission staffed a table at this year's Matawan Day held on Saturday October 13th, 2018. The event was held in downtown Matawan and included local businesses and vendors, not-for-profit organizations and charities, community groups and commissions, to name a few. This event is attended by well over a thousand people from Matawan and surrounding communities and is highly anticipated by all every year.

This year the Matawan Environmental Commission sponsored a Single Use Plastics Community Awareness display by local artist Joe Harvard. Initiated by local resident Yvette Reyes, this "Reuse, Refuse, Recycle, Respect Earth" campaign exhibited numerous art pieces constructed of single use plastics, designed to create and instill awareness of the harmful impacts of single use plastics on our planet. Especially intriguing to children, this display inspired creativity to recycle and reuse the everyday plastics that we encounter and use them to create art to beautify our world.

# 6.0 2019 GOAL

In 2019 we have added some new goals to the commission's agenda. If budgeting allows the most important project of 2019 will be to produce a Borough Natural Resource Inventory (NRI).

A NRI compiles information on important, naturally occurring resources within the Borough as well as important cultural sites and other infrastructure. NRIs provide a strong foundation for informed land-use planning and decision-making by identifying where resources occur and how they relate to existing development.

An NRI is an unbiased report of integrated data and provides baseline documentation for measuring and evaluating resource protection issues. The NRI is an objective index and description of features and their functions, rather than an interpretation or recommendation. Identifying significant environmental and cultural resources is the first step in their protection and preservation.

To date no NRI has ever been completed by the Borough of Matawan and it is our opinion that the Borough would benefit greatly from having one as part of its Master Plan. The initial research conducted will be focused on addressing the concerns deemed most immediate to the Borough. The NRI would include information on geology and soils, water resources, wildlife and habitats, climate, cultural resources and land use. The NRI is a living document which will be updated and amended to ensure it consistently reflects the needs of the community.

Together we can help document and protect the valuable natural and cultural resources of our community to ensure they continue to benefit future generations. We welcome the opportunity to talk to you in person regarding our proposal and the positive environmental and economic impacts this work could facilitate. Thank you for your consideration and for all that you do for our community.

Additionally, we will be continuing our efforts to reach a certification level in the Sustainable Jersey program. Sustainable Jersey is nonprofit organization that provides tools, training and financial incentives to support communities as they pursue sustainability programs. There are currently 443 NJ municipalities participating of which 203 have received certification. There are also some garden projects we may pursue this year based on repeated public interest are a demonstration rain garden, community garden, and pollinator gardens.
