#### <u>Privilege of the Floor – Agenda Items Only</u>

Mayor Buccellato opened the Privilege of the Floor.

Mayor Buccellato read a statement prior to the introduction of tonight's guests: During the less than thirteen years of Dr. Martin Luther King Jr.'s leadership the modern American Civil Rights Movement from December 1955 until April 4, 1968 African-Americans achieved more progress toward racial equality than the previous 350 years had produced. Dr. King is widely regarded as America's preeminent advocate of non-violence and one of the greatest non-violent leaders in our history. Drawing from inspiration from both his Christian faith and the peaceful teachings of Gandhi, Dr. King lead a non-violent movement in the late 50s and 60s achieve legal equality for African-Americans in the United States while others were advocating for freedom by any means including violence, Dr. King used the power of words and acts of non-violent resistance such as protest and grass roots organizing to achieve seemingly impossible goals. He went on to lead civil campaigns against poverty and international conflict always maintaining fidelity to his principles that men and women everywhere regardless of color or creed are equal members of the human family.

She asked for the Borough's support in sharing the occasion and will keep the Borough appraised of any proposed plans.

Reverend Steven Moore, Second Baptist Church. Reverend Moore thanked the Mayor stating Mr. Buccellato has been an inspiring presence over the last two years. We believe it will be a great thing for Matawan to come together on Martin Luther King's Day once a year in some form or fashion. Our ultimate goal is for all to worship, walk and do all the things we are supposed to do together as human beings and honor someone who has done great work and then begin to do our own.

Reverend Jeffrey Grey, Second Baptist Church. This will be a great opportunity to celebrate the diversity of this town. The Civil Rights Movement had many martyrs, black and white. I look forward to doing this and look for your support.
