regular meeting of the Borough Council of the Borough of Matawan, New Jersey, was held at the Matawan Municipal Community Center, 201 Broad Street, Matawan, New Jersey on June 6, 2013. The meeting was called to order at 7:00 PM by Mayor Buccellato presiding. Mayor Buccellato called the meeting to order, pursuant to Section 5 of the Open Public Meetings Act that adequate notice of this meeting has been provided in the notice which was published in the *Asbury Park Press* on January 9, 2013, by sending notice to *The Independent*, and by posting. Mayor Buccellato requested a roll call.

Powers and Deputy Chief Rick Derechailo, former Matawan Chief of Police Carmen Messina, and Former Mayor of Matawan and Freeholder, and now Assemblyman, Robert D. Clifton.

Mayor Buccellato asked everyone to stand for a moment of silence.

Mayor Buccellato asked everyone to stand in the Salute to the Flag presented by the Matawan Police Department Honor Guard asking everyone to remember former Councilman James Shea and Senator Frank Lautenberg.

Rev. John Scully, Pastor of St. Clement Church, Matawan, gave the Invocation.

Mayor Buccellato administered the Oath of Office of Chief of Police of the Borough of Matawan Police Department to Lt. Jason Gallo.

Chief Gallo thanked the Mayor, Council, his Department, the Fire and First Aid Departments, County and neighboring Departments for their overwhelming support and confidence, specifically, Lt. Ben Smith and Sgt. Thomas Falco. Chief Gallo also expressed his thanks to the residents for their support as always, but specifically, during the last few weather events – how everyone worked together to help each other. He also thanked his family for their unwavering support.

Rev. Jeffrey Gray, Pastor of the Second Baptist Church, Matawan, gave the Benediction.

Police Chief Gallo dismissed the Matawan Police Department.

At 7:16 PM Mayor Buccellato requested a motion for a brief recess. Councilwoman Clifton made the motion, seconded by Councilman Fitzsimmons. Council agreed. Motion passed.

At 7:18 PM Mayor Buccellato requested a motion to reconvene. Councilwoman Angelini made the motion, seconded by Councilman Fitzsimmons. Council agreed. Motion passed.

Mayor Buccellato read by title Resolution 13-06-02: Resolution to Read the Budget by Title Only at the Public Hearing. Mayor Buccellato requested a motion to approve. Councilman Fitzsimmons made the motion, seconded by Councilwoman Angelini. Council agreed. Motion passed.

Public Hearing – 2013 Budget

Mayor Buccellato requested a motion to open the 2013 Budget Public Hearing. Councilman Fitzsimmons made the motion, seconded by Councilwoman Clifton. Council agreed. Motion passed.

Councilman Fitzsimmons reported the 2012 fiscal year was truly a validation of the responsible fiscal management which has been a fiscal hallmark of this Council for the last five years. Despite a large number of successful tax appeals, a significant settlement with a former employee, and the expenses brought on by Super Storm Sandy, the Borough was able to weather a financial storm as well as the natural one. While many municipalities were borrowing hundreds of thousands and in some cases, millions of dollars to pay their bills, we were able to survive unscathed. The Temporary Emergency Appropriation of \$100,000.00 which we did as a precaution at the end of the year turned out to be unnecessary as FEMA unexpectedly reimbursed us in an amount in excess of that figure only days later. It is not by accident or by luck that we were prepared for these fiscal crises. Over the last five years Mayor Buccellato and this Council have relentlessly focused on ways to deliver services more efficiently. We've entered into several shared service agreements including our regional court; consolidated departments; refinanced debt at lower interest rates; entered into energy cooperative to save on energy bills; this year we have replaced our telephone system and carrier with an anticipated savings of \$12,000. It is this focus which has allowed us to absorb last year's unexpected costs and we will continue to make every effort to keep the cost of local government under control while delivering services to the residents of Matawan. With that said, I am proud to announce that this year's budget actually spends less money than last year's. In 2012 the final appropriation was \$10,734,270.00 and that includes the \$100,000.00 Emergency Appropriation. This year's budget comes in at \$10,554,843.00, a spending reduction of approximately \$180,000. The amount to be raised by taxes is \$7,484,009.00, an increase of just over \$72,000.00 from 2012. The municipal tax rate will be \$0.72 per \$100.00 of assessed value, a \$0.01 increase over last year's rate. For a home valued at \$300,000.00 that's an increase of only \$30.00 for the municipal portion of your taxes. Though spending was down yet our tax levy was up slightly; our non-tax revenue was significantly decreased, ie, railroad parking fees, traffic court fees, etc. Even though our spending was down that revenue was down more and we needed to offset that with the tax increase. Second, the unprecedented number of successful tax appeals. The 2012 tax appeal awards exceeded the budgeted amount of \$231,000.00. We have budgeted \$472,000.00 in 2013. This is a responsible budget and hard work by the Mayor, Council, current and former Administrators, Department Heads and our employees.

Mayor Buccellato opened the floor for public comment.

There were no comments.
