RESOLUTION 15-10-11 AUTHORIZING AWARD OF CONTRACT UNDER A NATIONAL COOPERATIVE PURCHASING AGREEMENT ELECTRICAL ENERGY GENERATION EQUIPMENT WITH RELATED ACCESSORIES, SERVICES AND SUPPLIES CATERPILLAR, INC. MATAWAN MUNICIPAL COMMUNITY CENTER GENERATOR

WHEREAS, the New Jersey Office of Emergency Management (NJOEM) informed the Federal Emergency Management Agency (FEMA) has awarded the Borough of Matawan a Hazard Mitigation Grant in the amount of \$75,000.00 to purchase and install one (1) permanent diesel fueled generator to supply emergency backup power during and after severe weather for the Matawan Municipal Community Center (MMCC), 201 Broad Street, Matawan, New Jersey 07747; and

WHEREAS, the NJOEM and the Borough of Matawan have entered into the attached Sub-Grant Agreement for the Hazard Mitigation Grant Program (CFDA #97.039) FEMA-DR-4086-NJ-366-R for the purchase and installation of said generator; and

WHEREAS, the Borough of Matawan has determined its beneficial participation in the National Joint Powers Alliance (NJPA), a municipal national contract agency, which establishes and provides nationally leveraged and competitively solicited purchasing contracts under the guidance of Uniform Municipal Contracting Law, for the purchase of said generator; and

WHEREAS, the Borough of Matawan is permitted to join national cooperative purchasing agreements under the authority of NJSA 52:34-6.2(b)(3) and hereby approves said Membership #29789; and

WHEREAS, the Borough of Matawan as Member #29789 of the NJPA has provided Notice of Intent to participate in the NJPA Contract #080613-CAT (Caterpillar, Inc.) for Alternative Energy Generation Related Equipment and Services to purchase Alternative Energy, Generator Set, Mobile Generator Set, Portable Generator Set, Diesel and Gas Generators said contract term is September 17, 2013 to September 17, 2017; and

NOW, THEREFORE, BE IT RESOLVED, the Council of the Borough of Matawan hereby awards the contract for the purchase of a generator for the MMCC as outlined in the attached quote to Foley Power Systems, a division of Caterpillar, Inc., 855 Centennial Avenue, Piscataway, New Jersey 08855 paid out of the Borough's Capital Line Item with reimbursement to be made with the \$75,000.00 grant monies.

Mayor Buccellato informed of his privilege of attending the Women's Club of Matawan's 100 year anniversary meeting. Al Savoline, of the Matawan Historic Commission, gave a most interesting lecture of the history of the organization, from its inception to around WWII. The Mayor said he was fascinated to learn that the Women's Club was the driving force behind establishing Memorial Park.

Mayor Buccellato asked Mr. Keady to update Council with a brief Engineer's Report. Mr. Keady informed the 2015 Road Program Contract 1 (Somerset, Crown, Ziegler Place and Wyckoff Street, Oak Knoll Drive, miscellaneous repairs to various Borough roads as well as the Annmar Drive water Main and miscellaneous traffic striping) bid opening received one bid which exceeded the Engineer's estimate. This time of year does not usually show many bidders. He will evaluate but recommends the Borough hold off for a few months (at least until the end of January) to re-bid.

Privilege of the Floor

Mayor Buccellato opened the Privilege of the Floor.

Nicholas Reeve, 1 Angelica Court, Matawan. Mr. Reeve informed the Freneau monument on Poet Drive is in need of maintenance as it is overgrown with brush. Mr. Ferrara stated he will inquire as to the monument's maintenance whether by the Historical Society and/or the DPW.

Mr. Ferrara then informed the Little Street Parking lot is scheduled for milling on October 22, paving on October 23, and striping on October 24. Residents in the area will receive written notice to move all vehicles from the lot no later than October 21. Mr. Ferrara thanked Council for approving the NJPA purchasing co-op for generator specs and bid process which will save the Borough a tremendous amount of money. Purchase through the cooperative places the burden of the bid process on NJPA at no cost to the Borough.

Fran Bucco, 79 Freneau Avenue, Matawan. Ms. Bucco related an incident wherein a Police vehicle performing a traffic stop was nearly invisible due to its coloring and lack of emergency lighting. Mayor Buccellato informed this is referred to as a 'stealth vehicle,' but will question the lighting with Police.

Nicholas Reeve, 1 Angelica Court, Matawan. Mr. Reeve related other parking lots in need of repair, such as the lot behind Maloney's and the AIM Dance Studio. The Mayor informed those lots, along with the ones down by the train station, are privately owned. The owner of the AIM Dance Studio lot opted not to participate in the repaying of his personal portion of the lot.

Mayor Buccellato closed the Privilege of the Floor.

Adjournment

Mayor Buccellato requested a motion to adjourn. Councilwoman Clifton made the motion, seconded by Councilwoman Gould. Council agreed. Motion passed.
