#### ORDINANCE 16-02

AMENDING AND SUPPLEMENTING THE BOROUGH OF MATAWAN CODE CHAPTER 30 – LAND USE PROCEDURES SECTION 30-1.2 – ALTERNATE MEMBERS CONCERNING THE CONSTITUTION OF THE UNIFIED PLANNING BOARD - ZONING BOARD OF ADJUSTMENT

WHEREAS, the Borough of Matawan has an established Unified Planning Board, as a result of a transition from two separate boards, namely a Planning Board and a Zoning Board of Adjustment, to a Unified board; and

WHEREAS, the currently established Unified Planning Board functions under the authority of the New Jersey Municipal Land Use Law, NJSA 40:55D-23; and

WHEREAS, the New Jersey statutory authority for Unified Planning Boards, as contained in the Municipal Land Use Law, permits municipalities to establish alternate members of the Unified Planning Board in Matawan's instance; however, the establishment, composition, and designation of those members must meet the statutory criteria set forth in NJSA 40:55D-23.1; and

**WHEREAS,** the foregoing amendment is not intended to have any impact on the statutorily permissible position of "Mayor's Alternate", who only attends in the event of the absence of the Mayor; and

WHEREAS, the Borough of Matawan has historically identified the alternate members as alternates for various classes of members of the said Unified Planning Board and not named them consistent with the statutory authority of NJSA 40:55D-23.1 as alternates for Class IV members; and

WHEREAS, it is the desire of the Mayor and Council to revise the current ordinance, namely 30-1.2 as it concerns Alternate Members only, in order to comply with the requirements of NJSA 40:55D-23.1.

#### NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL AS FOLLOWS:

- 1. The provisions of Section 30-1.2 are amended to read as follows:
- 30-1.2 Alternate Members.
- a. In addition to the regular members of the Unified Planning Board appointed pursuant to this section, there shall be appointed <u>four</u> alternate members <u>as follows</u> <u>appointed by the Mayor. They shall be designated Alternate Number One, Alternate Number Two, Alternate Number Three, and Alternate Number Four.</u>
  - 1. Class II: One (1) alternate member to be appointed by the Mayor.
  - 2. Class III: One (1) alternate member to be appointed by the Borough Council.
- 3. Class IV: Two (2) alternate members to be appointed by the Mayor. The alternates shall be designated at the time of appointment by the Mayor as "Alternate Number 1" and "Alternate Number 2."
- b. Alternate members shall serve in the absence or disqualification of the regular members of the Board. of the Class to which the alternate is appointed. The alternate members of Class IV shall serve in rotation during the absence or disqualification of any member or members of Class IV.
- c. Terms:
  - 1. Class II Alternate: a term expiring at the same time as the term of the regular member of Class II.
  - 2. Class III Alternate: a term expiring at the same time as the term of the regular member of Class III.
- 3. Class IV-Alternates: a term of two (2) years beginning on January 1 of the year in which such alternate is appointed, however, the terms of the alternate members shall be such that the term of not more than  $\frac{\partial P}{\partial P}$  (2) alternate members shall expire in any one (1) year; provided that in no instance shall a term of alternate members first appointed exceed two (2) years.

- d. Vacancy. A vacancy in any class which occurs otherwise than by expiration of term shall be filled by appointment as above provided for the unexpired term only.
- e. No alternate member shall be permitted to act on any matter in which he or she has either directly or indirectly any personal or financial interest. An alternate member may be removed by the Governing Body for cause. Removal can be made only upon a hearing which shall be public if the alternate member so requests.
- Alternate members may participate in discussions of the proceedings but may not vote except in the absence or disqualification of a regular member of any class. A vote shall not be delayed in order that a regular member may vote instead of an alternate member. In the event that a choice must be made as to which alternate member is to vote, "Alternate Number One" shall vote succeeded by Alternate Number Two, Alternate Number Three, and Alternate Number Four in order of precedence, if eligible to vote.
- If any part of this Ordinance is deemed to be illegal or ineffective, the other provisions shall nonetheless remain in force.

This Ordinance shall take effect upon second reading and publication according to law.

#### **Privilege of the Floor**

Mayor Altomonte opened the Privilege of the Floor.

Robert Montfort, 209 Main Street, Matawan. Mr. Montfort related previous correspondence addressed to Mayor and Council outlining planned events in July 2016 by the Matawan Historical Society's commemoration of the 100<sup>th</sup> anniversary of the Matawan Creek July 12, 1916 shark attacks. Mr. Montfort asked Council for a Resolution authorizing permission to erect a monument in Memorial Park. Mr. Montfort also related pending grant applications and funding for Burrowes Mansion renovations.

Curtis Roinstad, 13 Church Street, Matawan. Mr. Roinstad also spoke about the 100<sup>th</sup> anniversary of the shark attacks in Matawan.

Council requested drawings of the proposed monuments and their location.

Fran Bucco, 79 Freneau Avenue, Matawan. Mayor Altomonte greeted Ms. Bucco informing he called 'The Preserve' to discuss the ongoing issue with the garbage. He mentioned the various ideas that were discussed with the management company. Ms. Bucco expressed her frustration. Councilman Reeve then asked how long the issue with 'The Preserve' was going on and Ms. Bucco said since it was built, about six years approximately. Councilman Reeve then asked what the previous mayor did for the situation. Ms. Bucco then said that he was doing the same thing.

Paul Buccellato, 5 Essie Drive, Matawan. Mayor Buccellato explained the history of 'The Preserve' and how it was approved and built prior to his term as Mayor.

Fran Bucco, 79 Freneau Avenue, Matawan. Ms. Bucco stated she did not approve of Councilman Reeve's demeanor and tone. She then asked Mayor Altomonte for his plan to resolve the issue. Mayor Altomonte said he will call The Preserve again tomorrow. A debate then started about what the next step would be. Mr. Ferrara interjected, stating that this was a

private legal matter which has been referred to Mr. Menna for his recommendation. Mr. Menna then explained the next steps, to the best of his knowledge.

Brett Cannon, 217 Middlesex Road, Matawan. Mr. Cannon questioned Councilman Urbano for the reason for voting against Resolution 16-03-25. Councilman Urbano informed it is a matter of responsible governing with a budget has not been introduced or adopted. Councilman Caldon then interjected, explaining the nuances of the Resolution and what it meant. Mr. Cannon related the poor condition of the building at 150 Main Street. Discussion took place, circling back to the issue at 'The Preserve'.

Fran Bucco, 79 Freneau Avenue. Ms. Bucco stated Mayor Buccellato and the Council had nothing at all to do with the situation with 'The Preserve'. She then scolded everyone for all the ongoing bickering asking Mayor Altomonte to not allow certain behavior. Mayor Altomonte stated everyone has the privilege to speak, but conceded it did get out of line.

Anthony Jones, 11 Clinton Street, Matawan. Mr. Jones introduced himself as a member of The Shore Knights. He related The Shore Knights assisted renovation of Clinton Street Park stating they have some ideas for the park, and would like to work with the Recreation Department with Councilwoman Clifton as Council representative. Councilwoman Clifton encouraged Mr. Jones to develop a proposal and also attend the Recreation Department meetings.

Mayor Altomonte closed the Privilege of the Floor.

#### **Adjournment**

Mayor Altomonte requested a motion to adjourn. Councilman Reeve made the motion, seconded by Councilwoman Clifton. Council agreed. Motion passed.
