Mayor Altomonte asked everyone to stand for a Salute to the Flag.

Mayor Altomonte asked everyone to stand for a Moment of Silence.

<u>Privilege of the Floor – Agenda Items Only</u>

Mayor Altomonte opened the Privilege of the Floor for Agenda Items Only.

There were no comments.

Mayor Altomonte requested a motion to close the Privilege of the Floor for Agenda Items Only. Councilman Vergaretti made the motion, seconded by Councilman Cannon. Council agreed. Motion passed.

Discussion Items

Approval of Borough Contract Work to be Performed on Saturdays

- i. Main Street Streetscape Soil Borings
- ii. Gravelly Brook Park Improvements Program Phase I

Mr. Menna informed in order to minimize interruption to business and traffic flow, T&M Associates is requesting Council authorization to perform some construction work on Saturdays for Main Street Streetscape Soil Borings.

Mayor Altomonte related a recent pre-construction meeting for Gravelly Brook Park wherein the Contractor asked if they needed to work on a Saturday or two would Council approve. Mayor said rather than just a Saturday or two, the Mayor suggests a 90 day window for the Contractor with no additional cost to the contract.

Council agreed to the addition of a Resolution to tonight's Agenda for Council approval of Construction to be Performed on Saturdays for Borough of Matawan Projects – Main Street Streetscape and Gravelly Brook Park Improvements Phase I.

Clinton Street Parking

Councilman Cannon informed he and Mayor Altomonte were asked by the residents of Clinton Street to examine the area, and spoke to the Chief of Police requesting his evaluation and recommendation. The Chief of Police recommends that parking be prohibited on Clinton Street as the width of the roadway makes it a safety concern as emergency vehicles cannot pass. Tom Burke, 16 Clinton Street, Matawan. Mr. Burke states parking on Clinton Street is an ongoing problem. With a recent fire there was an issue with fire apparatus being able to get in-and-out of the area. There are also issues with the garbage trucks and school busses operating along the street.

Carlos Platero, 9 Clinton Street, Matawan. Mr. Platero reiterated Mr. Burke's statement(s).

Clerk's Report

Ms. Wynne reminded all present that the 2017 Annual Financial Disclosure Statements is due May 30, 2017. She informed at the direction of the Monmouth County Board of Elections, effective immediately, residents of voting District 2, Hook and Ladder Firehouse located at 161 Broad Street, will now vote at the Matawan Municipal Community Center here at 201 Broad Street. This will begin with the June 6, 2017 Primary Election and continue for ALL future elections. Residents in the District were notified via first class mail; the notice is currently posted on the MMCC marquee, it is posted to the Borough's website, and two SwiftReach (reverse 911) calls will be made to all residents prior to June 6. A notice will be posted at the Hook and Ladder Firehouse on June 6 to remind District 2 voters to vote at the MMCC.

DPW, Planning/Zoning Board, Main Street Development, Property Maintenance

Councilman Cannon reported the DPW reached out to the County about 1½ months ago regarding the crosswalks on Main Street and Broad Street, specifically leading to Terhune Park, and the County completed the work today. The Main Street Development hit a road block in the parking study, stating that Main Street is not structurally wide enough to do the desired parking plan. As of now, Main Street parking is legally compliant with its preexisting conditions, and they will explore alternative options. This INTERLOCAL SERVICES AGREEMENT (this "Agreement"), by and between the Borough of Matawan, in the County of Monmouth, New Jersey, a municipal corporation of the State of New Jersey (the "Borough"), and the Matawan-Aberdeen Regional School Board of Education, in the County of Monmouth, New Jersey, a school district and political subdivision of the State of New Jersey (the "Board") (collectively the "Parties"), dated as of May 16, 2017.

WITNESSETH:

WHEREAS, the Borough and Board have worked in cooperative spirit to meet the short and long term needs of Matawan; and

WHEREAS, the Borough and Board have certain needs that are best served through interlocal cooperation; and

WHEREAS, <u>N.J.S.A.</u> 40:8A-1 <u>et seq.</u>, authorizes and encourages a municipality and a board of education to enter into contracts for the joint provision within their jurisdiction of any service which either party to Agreement is empowered to render within its own jurisdiction; and

WHEREAS, the purposes of the Borough and the Board can be accomplished effectively through this Agreement; and

WHEREAS, the Borough and Board desire to enter into this Agreement; and

WHEREAS, the Borough has approved the execution of this Agreement by resolution adopted on May 16, 2017 and the Board has approved the execution of this Agreement by resolution adopted on ______.

NOW, THEREFORE, the parties hereto mutually agree as follows:

- Section 1. Joint Cooperation. The Borough and Board shall provide, in cooperation with or on behalf of the other any desired services authorized by law (including, but not limited to, the use, lease or provision of either or both Party's employees or property, whether real or personal ("Property"), as may be from time to time authorized by joint or concurring resolution of the Parties ("Services Resolution").
- Section 2. Services Resolutions, Procedures. Each Services Resolution shall be individually tailored and shall specifically indicate the nature of the service to be performed, Property to be used, and the approval of both Parties in providing the joint cooperating Property. The Services Resolution shall expressly make reference to this Agreement as the controlling document and shall incorporate the terms of this Agreement by reference. Upon passage by both Parties, the Services Resolution shall be appended to this Agreement. In the event that the Services Resolution and this Agreement conflict, the terms of this Agreement shall control. In no event may the terms of a Services Resolution modify this Agreement.
- **Section 3. Other Agreements Unaffected.** All other interlocal services agreements, whether currently existing or not, shall remain in full force and effect and shall not be governed by the terms of this Agreement.
- Section 4. Maintenance and Payment. Unless otherwise specified in a Services Resolution, each Party agrees to maintain its own Property. Any and all payments made for the use of Property in accord with a Services Resolution shall be specified in and made pursuant to that Services Resolution.
- **Section 5. Standards.** Services performed through the use of the Property pursuant to a Services Resolution shall be governed by the reasonable satisfaction standard, unless a different standard is specified in such Services Resolution.
- **Section 6.** No Assignment. The rights and the obligations under this Agreement and any Services Resolution shall not be assigned by either Party without the written consent of the other.
- Section 7. Term of Agreement and Services Resolution. This Agreement shall be for a term of one (1) year from the date hereof and may be extended by mutual agreement of the Parties. Each Services Resolution shall be for such time periods as specified in said Services Resolution. Either party may cancel this Agreement, or any Services Resolution covered hereunder, on 90 days written notice to the other party. In the event that this Agreement ceases, any and all Services Resolutions passed in accordance with this Agreement shall also cease.
- **Section 8. Fees and Fee Shifting.** Attorney's fees and fee shifting are prohibited under this Agreement and neither Party may recover fees from the other Party in the event that litigation or arbitration or any proceeding is brought to enforce the obligations of any Party under this Agreement or any Services Resolution.
- Section 9. Joint Insurance. The Parties shall maintain a joint insurance policy in the usual and customary amount and in a form acceptable to both Parties to insure the Borough and the Board's use of each other's Property. At the option of both Parties, the Parties may agree that a specific Services Resolution and the Property used thereunder not be covered by the joint insurance policy, and instead be covered by a separate policy or other insurance arrangement.
- Section 10. Disputes. The Parties agree that, in the event a dispute arises as to the interpretation of this Agreement or a Services Resolution pursuant to this Agreement, the Borough Administrator, on behalf of the Borough, and the Superintendent of Schools, on behalf of the Board, shall be notified. The Borough Administrator and Superintendent of Schools shall immediately confer on the disputed issue and attempt to reach an accord. If the dispute cannot be rectified, the matter shall be submitted to mediation, failing which, the matter shall be submitted to binding arbitration. New Jersey Law shall govern this Agreement and any Services Resolution pass pursuant to the same.
- Section 11. Efficiency and Public Benefit. The Borough and the Board concur that this Agreement is being undertaken on behalf of the general public of the Borough of Matawan as the Agreement achieves economics and efficiencies beneficial to the constituency of the Borough of Matawan.

ORDINANCE 17-08 AMENDING AND SUPPLEMENTING THE CODE OF THE BOROUGH OF MATAWAN CHAPTER V – ANIMAL CONTROL SECTION 5:8 1(A) – REGULATING THE SALE OF DOGS AND CATS AND

SECTION 5:8.1(A) – REGULATING THE SALE OF DOGS AND CATS AND PROVIDING FOR A PROHIBITION ON THE SALE OF CERTAIN DOGS AND CATS FROM PET SHOPS

WHEREAS, a significant number of puppies and kittens sold at pet shops come from commercial breeding facilities where the health and welfare of the animals are not adequately provided for ("puppy mills" and "kitten mills", respectively); and

WHEREAS, the documented abuses endemic to puppy and kitten mills include over-breeding; inbreeding; minimal to non-existent veterinary care; lack of adequate space; and lack of adequate exercise; and

WHEREAS, the inhumane conditions in puppy and kitten mill facilities lead to health and behavioral issues in the animals bred in those facilities, which many consumers are unaware of when purchasing animals from pet shops and which can result in exorbitant financial and emotional costs on consumers; and

WHEREAS, current Federal and State regulations do not adequately address the sale of puppy and kitten mill dogs and cats in pet shops; and

WHEREAS, restricting the retail sale of puppies and kittens to only those that are sources from shelters or rescue organizations is likely to decrease the demand for puppies and kittens bred in puppy and kitten mills, and is likely to increase demand for animals from animal shelters and rescue organizations; and

WHEREAS, according to the New Jersey Department of Health 2014 Animal Intake and Disposition Survey, due in large part to pet overpopulation, more than 20,000 dogs and cats are euthanized in New Jersey animal shelters annually and restricting the retail sale of puppies and kittens to only those that are sourced from animal shelters and rescue organizations will likely reduce pet overpopulation and the burden on such agencies and financial costs on local taxpayers; and

WHEREAS, across the country, thousands of independent pet shops as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats and many of these shops collaborate with local animal shelters and rescue organizations to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, this Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a breed-specific rescue organization or shelter, or from a hobby breeder where the consumer can see directly the conditions in which the dogs or cats are bred, or can confer directly with the hobby breeder concerning those conditions; and

WHEREAS, the Governing Body finds that it is in the best interests of the Borough to adopt reasonable regulations to protect the citizens of the Municipality who may purchase cats or dogs from a pet shop; help prevent an inhumane environment in the Borough.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Matawan, in the County of Monmouth, State of New Jersey, as follows:

SECTION ONE: Chapter V, Ordinance 5-8.1 (Regulation of Kennel, Pet Shop, Shelter or Pound) of "Animals" of the Code of the Borough of Matawan, be and the same is hereby amended and supplemented to add thereto the following Ordinance:

Ordinance 5-8.1(a): Regulating the Sale of Dogs and Cats.

(i) Definitions.

The following words and terms shall have the meanings herein indicated for the purposes of the Article:

ANIMAL CARE FACILITY means an animal control center or animal shelter, maintained by or under contract with any state, county or municipality, whose mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes or rescue organizations.

ANIMAL RESCUE ORGANIZATION means any not-for-profit organization which has tax-exempt status under Section 50I(c)(3) of the United States Internal Revenue Code, whose mission and practice is, in whole or in significant part the rescue and placement of animals in permanent homes.

OFFER FOR SALE means to sell, offer for sale or adoptions, advertise for the sale of, barter, auction, give away or otherwise dispose of a dog or cat.

PET SHOP means a retail establishment where dogs and cats are sold, exchanged, bartered or offered for sale as pet animals to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization, as defined herein.

(ii) Restrictions on the Sale of Dogs and Cats.

A. A pet shop may offer for sale only those dogs and cats that the pet shop has obtained from or displays in cooperation with:

- 1) An animal care facility; or
- 2) An animal rescue organization.

B. A pet shop shall not offer for sale a dog or cat that is younger than eight weeks old.

SECTION TWO. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repeated to the extent of such inconsistencies.

SECTION THREE. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgement shall not affect, impair or invalidate the remainder of this Ordinance.

SECTION FOUR. This Ordinance shall take effect immediately upon its Passage and publication according to law.

The Clerk announced the public hearing will be held at 7:00 PM on June 7, 2017.
