Mayor Altomonte called the meeting to order at 7:00 PM requesting a roll call.

Mayor Altomonte asked everyone to stand for a Moment of Silence.

Best Practices Inventory

Mayor Altomonte requested a motion to open the floor for Best Practices Inventory. Councilman Livesey made the motion, seconded by Councilwoman Buckel. Council agreed. Motion passed.

Mr. Ferrara announced each year the Borough participates in Local Finance Board's 'Best Practices Inventory', explaining the process and how it affects a municipality's State aid. The Borough scores well every year, and this year was no exception scoring well above the minimum needed to receive State aid. He recommended the Council adopt it. Approval of Firefighter

Mayor Altomonte requested a motion to approve Borough of Matawan Volunteer Firefighter Applicant, Anthony Provenzano. Councilwoman Salvatore made the motion, seconded by Councilwoman Buckel. Council agreed. Motion passed.

Approval of Minutes

Mayor Altomonte requested a motion to approve the minutes of the October 1, 2019 Council Meeting. Councilman Reeve made a motion, seconded by Councilwoman Buckel. Council agreed. Motion passed.

Old Business

Mayor Altomonte read by title Ordinance 19-17: An Ordinance of the Council of the Borough of Matawan Approving an Amendment to the Redevelopment Plan for the Designated Redevelopment Area in the Vicinity of the Matawan Train Station Pursuant to the New Jersey Local Redevelopment and Housing Law (NJSA 40A:12A-1, et seq.). Mayor Altomonte requested a motion to open the public hearing. Councilman Reeve made the motion, seconded by Councilwoman Salvatore. Council agreed. Motion passed.

Linda Clifton, 25 Crescent Place, Matawan. Ms. Clifton requested clarification. Mr. Menna explained the amendment incorporates the redevelopment standards, enabling the Borough to be in compliance with the New Jersey law regarding low-and-moderate income housing standards. He noted that this was necessary to pass this to move forward with the redevelopment that takes place at the train station. Ms. Clifton asked if this was a mandatory; Mr. Menna replied that it was. Ms. Clifton then asked what if the Council decided that it didn't want to add more residential housing. Mr. Menna replied the amendment only applied to the redevelopment at the train station, stating that it does not apply to the commercial element, should there be one. Ms. Clifton asked again if it was mandatory to have residential down at the train station. Mr. Menna informed there is no actual adopted plan. He noted most train station property is owned by New Jersey Transit, and residential housing will be the central component, financially, for them. If it wasn't done, the Borough will probably be sued by Fair Share Housing Alliance.

Ms. Clifton requested clarification of Ordinance 19-19. Mr. Keady explained the need for the revision. Ms. Clifton asked if it was increasing fees slightly, and Mr. Keady agreed. He then explained the process of requesting a permit to cut the surface of public property. Mr. Menna further explained that the need arose because the CFO had advised the Clerk there were many instances when after the work was done, the Borough was trying to collect any override on the escrow accounts. It will be better to collect in advance and then return any unused funds.

Fran Bucco, 79 Freneau Avenue, Matawan. Ms. Bucco asked if the Borough will have to build more low-income housing. Councilwoman Gunn stated there is not enough information to make that decision yet.

Scott Selby, 11 Angelica Court, Matawan. Mr. Selby asked about the Borough liability regarding not having affordable housing. Mr. Menna elaborated what the outcome could be if the redevelopment of the train station occurs. He advised having a plan in place. Mr. Selby asked what the criteria was used to determine what percentage of low-income housing will the Borough need to conform to the State. Mr. Menna explained it was based on an existing formula. If 100 new units are created at the train station, 15%-20% will have to be dedicated to low-and-moderate income housing. Mr. Selby asked if the community could vote on this. Mr. Menna informed it is a constitutional imperative, and not a referendum. Mr. Selby then asked if the community could vote to decide whether the development occurs at the train station. Mr. Menna said that application will probably have to go before the Planning Board, who would vote whether to approve it or not.

Mayor Altomonte requested a motion to close the public hearing. Councilman Reeve made the motion, seconded by Councilwoman Salvatore. Council agreed. Motion passed. Mayor Altomonte read by title Ordinance 19-17: An Ordinance of the Council of the Borough of Matawan Approving an Amendment to the Redevelopment Plan for the Designated Redevelopment Area in the Vicinity of the Matawan Train Station Pursuant to the New Jersey Local Redevelopment and Housing Law (NJSA 40A:12A-1, et seq.), requesting a motion to adopt. ORDINANCE 19-17

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF MATAWAN APPROVING AN AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE DESIGNATED REDEVELOPMENT AREA IN THE VICINITY OF THE MATAWAN TRAIN STATION PURSUANT TO THE NEW JERSEY LOCAL REDEVELOPMENT AND HOUSING LAW (NJSA 40A:12A-1, ET SEQ.)

WHEREAS, on July 5, 2000, the Borough Council of the Borough of Matawan (the "Governing Body") approved Resolution No. 00-07-08, which designated certain lands in the vicinity of the train station as a "Redevelopment Area" pursuant to the Local Redevelopment and Housing Law (NJSA 40A:12A-1 et seq.); and

WHEREAS, the New Jersey local Redevelopment and Housing Law, NJSA 40A:12A-1 et seq., authorizes the Borough Council of the Borough of Matawan ("the Governing Body") to adopt by ordinance redevelopment plans for areas in need of redevelopment or rehabilitation; and

WHEREAS, the Governing Body previously adopted the Redevelopment Plan (the "Redevelopment Plan") for the Designated Redevelopment Area in the Vicinity of the Matawan Train Station by Ordinance on April 30, 2001, with subsequent amendments adopted on December 1, 2015 and May 15, 2018; and

WHEREAS, in accordance with the provisions of the New Jersey Local Redevelopment and Housing Law, NJSA 40A:12A-1 et seq. (the "LRHL"), the Governing Body authorized the preparation of an amendment to the redevelopment plan for the Designated Redevelopment Area in the Vicinity of the Matawan Train Station, in the tract defined as Blocks 1, 2, 3, 4 and 11.01, and a portion of Block 11, including Lots 23, 24, 25.01, 26, 27, 29, 30, 40, 41 and 42; and

WHEREAS, the Borough's planning consultant, T&M Associates, has prepared a third amendment to the redevelopment plan for the Designated Redevelopment Area in the Vicinity of the Matawan Train Station (the "Transit Station Redevelopment Plan Amendment"); and

WHEREAS, pursuant to NJSA 40A:12-7, the Governing Body referred the Redevelopment Plan Amendment to the Planning Board for review; and

WHEREAS, the Governing Body hereby determines that the Redevelopment Plan is necessary and appropriate and will effectuate redevelopment and rehabilitation within the Borough.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Matawan, in the County of Monmouth, that the provisions of the section entitled "Affordable Housing Standards" of the Transit Station Redevelopment Plan, which begins on Page 7, is hereby repealed in its entirety and replaced with the following: "Affordable Housing Standards: Any multi-family residential component of the redevelopment project shall include a set-aside for very low-, low-, and moderate-income households in conformance with the Uniform Housing Affordability Controls, N.J.A.C. 5:80-26.1- For inclusionary projects in which the low- and moderate-income units are to be offered for sale, the appropriate set-aside percentage is 20 percent; for projects in which the low- and moderate-income units are to be offered for rent, the appropriate set-aside percentage is 15 percent. The terms and conditions for the provision of affordable housing shall be incorporated into all development approvals and shall be further set forth in a redevelopment agreement between the redeveloper and the redevelopment entity of the Borough of Matawan, and in relevant provisions of the Borough's affordable housing ordinance, as the case may be."

BE IT FURTHER ORDAINED, by the Borough Council of the Borough of Matawan, in the County of Monmouth, that the Amendment to the Redevelopment Plan is hereby adopted, and the provisions of the Transit Station Redevelopment Plan shall be revised accordingly.

BE IT FURTHER ORDAINED, that all prior Ordinances that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

BE IT FURTHER ORDAINED, that this Ordinance shall become effective immediately upon final passage and publication as required by law, as the "Ordinance Approving an Amendment to the Transit Station Redevelopment Plan."

ORDINANCE 19-19

AMENDING ORDINANCE 19-09

AMENDING AND SUPPLEMENTING THE CODE OF THE

BOROUGH OF MATAWAN CHAPTER 21

STREETS, SIDEWALKS, CURBS, DRIVEWAYS, SECTION 21-1, STREET, SIDEWALKS, CURB AND

DRIVEWAY OPENINGS

WHEREAS, the Administrator and Borough Engineer have recommended the adoption of this revision to Chapter 21 – Streets, Sidewalks Curbs, Driveways, Section 21-1, Street, Sidewalks, Curb and Driveway Openings.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Matawan that it herewith amends and supplements Chapter 21 – Streets, Sidewalks Curbs, Driveways, Section 21-1, Street, Sidewalks, Curb and Driveway Openings as follows:

Chapter 21, Section 21-1.2 – Is hereby amended and supplemented as follows:

21-1.2 Permit Required; Fees.

No person shall make an excavation or place any form of construction in, over or upon any public road, street or right of way, curb, sidewalk or driveway under the jurisdiction of the Borough without first making application for and obtaining a written permit from the Borough Engineer on the prescribed forms and upon the minimum payment of the application fee of one hundred dollars (\$100.00).

Permission to make an opening in or tear up the surface, curb or sidewalk of a road or street shall not carry with it any right to make drainage, sewer, water, gas, oil, steam, electric or telephone connections. A separate permit to make such connections must be obtained from the proper officials having jurisdiction thereof. The applicant shall make application for and obtaining a written permit from the Borough Engineer, or appropriate official, on the prescribed forms and upon the minimum initial payment of the review fee of six hundred dollars (\$600.00). Additional review fees may be required by the Borough Engineer if determined to be necessary.

If necessary and desirable in the opinion of the Borough Engineer, the permittee shall submit plans and specifications, in duplicate, which plans will indicate the extent of the proposed work within the Borough. The permittee shall promptly submit a copy of the permit to the Chief of Police. The Chief of Police shall notify the appropriate volunteer fire companies and first aid squads.

All work shall be performed and paid for by the person obtaining the permit.

Chapter 21, Section 21-1.3(d) – Is hereby amended and supplemented as follows:

21-1.3(d) Inspection Fee Escrow.

d. Inspection Fee Escrow. The applicant shall post an escrow with the Borough Clerk to defray the cost of inspection of the street opening and paving restoration by the Borough Engineer. The fee shall be equal to ten percent (10%) of the cash performance guarantee amount with a five hundred dollar (\$500.00) minimum. The applicant shall notify the Borough seven (7) days prior to commencement of work and at the completion of the work. Additional inspection fees may be required by the Borough Engineer if determined to be necessary.

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with the provisions of this ordinance shall be and the same are hereby repealed.

BE IT FURTHER ORDAINED, if any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED, this ordinance shall take effect upon final passage and publication as provided by law.

RESOLUTION 19-10-16

RESOLUTION TO URGE VOTERS TO SUPPORT THE REFERENDUM ON THE ELECTION BALLOT IN NOVEMBER, SO THAT VETERANS OR WIDOWED SPOUSES OF VETERANS WHO RESIDE IN CONTINUING CARE RETIREMENT COMMUNITIES (CCRC) WILL BE ELIGIBLE FOR PROPERTY TAX DEDUCATION

WHEREAS, the State Constitution for New Jersey authorizes veterans and widowed spouses of veterans who served in active duty during war and other times of emergency to receive a property tax deduction, in the amount of \$250.00 per year, in well-deserved recognition of their service to our country; and

WHEREAS, veterans and widowed spouses of veterans who reside in Continuing Care Retirement Communities (CCRC) have been unfairly denied eligibility for the \$250.00 property tax deduction because they do not own their units, even though they instead contribute to property taxes through a monthly payment, and even though they have made the same sacrifices as all veterans in our great country; and

WHEREAS, there are twenty-five CCRCs in the State which collectively house approximately 2,500 veterans or widowed spouses who are being denied the property tax deduction; and

WHEREAS, Senator Vin Gopal has sponsored legislation (S1331), that has been approved by the Senate and General Assembly, to extend the deduction to veterans and their widowed souses in CCRCs; and

WHEREAS, the extension of the deduction, because it requires an amendment to the State Constitution, must be approved by the voters at the ballot in November before it will become valid and effective; and

WHEREAS, the Mayor and Borough Council now desire to memorialize their support of the referendum on the ballot in November, and to urge the voters of this State to vote in favor of the property tax deduction for veterans and widowed spouses of veterans who reside in CCRCs.

NOW, THEREFORE, BE IT RESOLVED that the Council of the Borough of Matawan, urges voters to support the referendum on the ballot in November 2019, so that veterans and widowed spouses of veterans who reside in Continuing Care Retirement Communities (CCRC) will be eligible for the \$250.00 property tax deduction.
