ORDINANCE 25-01

AMENDING AND SUPPLEMENTING THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF MATAWAN CHAPTER 2 – ADMINISTRATION, ARTICLE VI – BOARDS, COMMITTEES AND COMMISSIONS, SECTION 2-40 – DISABILITY ACCESSIBILITY COMMITTEE, SUBSECTION 2-40.5 – ORGANIZATION

WHEREAS, the Borough of Matawan recognizes the need to amend certain provisions of Chapter 2, Article VI, Section 2-40, Subsection 2-40.5(b) to improve the scheduling flexibility of the Disability Accessibility Committee's reorganization meeting.

NOW, THEREFORE, BE IT ORDAINED, the Mayor and Council of the Borough of Matawan, County of Monmouth, State of New Jersey, that the Revised General Ordinances of the Borough of Matawan, Chapter 2, Article VI, Section 2-40, Subsection 2-40.5(b), shall be amended and supplemented as follows:

- b. The Disability Accessibility Committee shall hold its reorganization meeting on a date determined and set by resolution during the annual reorganization meeting of the governing body. At such time, the Committee will set dates for their quarterly meetings.

BE IT FURTHER ORDAINED, any Ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistencies only.

BE IT FURTHER ORDAINED, if any provisions of this Ordinance, or the application of such provision to any person or circumstance is declared invalid, such invalidity shall not affect the other provisions or applications of this Ordinance, which can be given effect, and to this end, the provisions of this Ordinance are declared to be severable.

BE IT FURTHER ORDAINED, this Ordinance shall take effect immediately upon following the passage, adoption and publication pursuant to New Jersey State law.
