PUBLIC NOTICE IS HEREBY GIVEN that sealed proposals will be received by the Borough of Matawan, Monmouth County, New Jersey on **Wednesday, November 1, 2017** at 10:00 AM prevailing time at the Borough of Matawan, Matawan Municipal Community Center, 201 Broad Street, Matawan Borough, NJ 07747 at which time and place the Bid packets will be publicly unsealed and its contents announced in public for the **MATAWAN RECYCLING CENTER**.

All work on this contract shall be completed within ninety (90) calendar days.

The Work of this Contract includes milling and asphalt paving, reinforced concrete pads, construction of a concrete bin block wall, traffic striping and markings, construction of bollards, construction of concrete curb, installation of facility control equipment, which include automatic barrier gates, vehicle detector, and access control unit and software, and restoration of the project area at the Matawan Recycling Center.

Contract Documents and Drawings for the proposed work, which have been prepared by the consulting Engineer, James A. Priolo, P.E., of the firm of Maser Consulting PA, are available at the office of said Engineer at One River Center – Building Two, 331 Newman Springs Road, Red Bank, New Jersey, and may be inspected by prospective bidders during business hours.

Bidders will be furnished with a copy of the Contract Documents by request upon proper notice and payment of a non-refundable charge of Seventy-Five dollars (\$75.00) payable to Maser Consulting PA to defray the cost thereof. Proposals must be made on the standard Proposal Forms in the manner designated in the Contract Documents, must be enclosed in sealed envelopes bearing the name and address of the Bidder, and the name of the work on the outside; addressed to Karen Wynne, Municipal Clerk, Borough of Matawan; and must be accompanied by a statement of Consent of Surety from a surety company authorized to do business in the State of New Jersey and acceptable to the Borough and either a Bid Bond or a Certified Check drawn to the order of Treasurer of the Borough of Matawan for not less than ten percent (10%) of the amount bid, except that the check need not exceed \$20,000.00. The successful bidder is hereby notified that a performance bond for the full amount of the project is required.

The award of the contract for this project will not be made until the necessary funds have been provided by the Borough of Matawan in a lawful manner.

The Borough of Matawan or the Engineer reserves the right to require a complete financial and experience statement from prospective bidders showing that they have satisfactorily completed work of the nature required before furnishing proposal forms or specifications, or before awarding the Contract.

Proposals for this Contract will be accepted only from bidders who have properly qualified in accordance with the requirements of the Contract Documents.

The right is also reserved to reject any or all bids or to waive any informalities where such informality is not detrimental to the best interest of the Borough of Matawan. The right is also reserved to increase or decrease the quantities specified in the manner designated in the Specifications.

The successful bidder shall be required to comply with the following:

- A. Affirmative Action requirements (PL 1975, C.127, NJSA 10:5-31 et. seq. and NJAC 17:27 et. seq.).
- B. The provisions of the New Jersey Prevailing Wage Act (NJSA 34:11-56.25 et. seq.).
- C. Anti-Kickback Regulations under Section 2 of the Act of June 13, 1934, known as the Copeland Act.
- D. Worker and Community Right-to-Know Act (NJSA 34:5A-1).

Moreover, the bid must be accompanied by a list of names and addresses of all stockholders owning 10% or more of the stock in accordance with the provisions of the Public Disclosure Law (PL 1988, C.33, NJSA 52:25-24.2).
