UNDERTAKE ANY NECESSARY STEPS FOR THE PUBLIC RE-
ADVERTISEMENT AND ACCEPT BIDS FOR THE SOLID WASTE AND
RECYCLABLE MATERIALS COLLECTION SERVICE CONTRACT**

WHEREAS, the Borough of Matawan previously authorized the receipt of bids for the Borough of Matawan Solid Waste and Recyclable Materials Collection Service Contract; and

WHEREAS, pursuant to law the Borough of Matawan solicited bids and received one (1) bid for the aforesaid Contract; and

WHEREAS, according to the NJSA 40A:11-13.2a the lowest bid substantially exceeds the cost estimates for services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Matawan that pursuant to NJSA 40A:11-13.2a as the lowest bid substantially exceeds the cost estimates for services, all bids for Solid Waste and Recyclable Materials Collection Service Contract be and are hereby rejected.

BE IT FURTHER RESOLVED by the Council of the Borough of Matawan that it herewith authorizes T&M Associates to undertake any necessary steps for the public re-advertisement and acceptance of bids for the Solid Waste and Recyclable Materials Collection Service Contract at no additional cost.

BE IT FURTHER RESOLVED that a true certified copy of this Resolution shall be forwarded to the following Borough of Matawan Departments: Clerk, Finance, Public Works as well as Robert R. Keady, Jr. of T&M Associates, the Borough Engineer and all bidder(s).
